8:45 a.m. – 10:15 a.m.	<p><b>Session 1 ~ NERC Reliability Standards and Regulatory Issues</b></p> <p><b>Description:</b> We have a significant vested interest in the reliability and resilience of the North American Bulk electric system and many of us have the responsibility to adopt and oversee reliability standards and to conduct compliance and enforcement activities. We must also be mindful of their resulting costs to ratepayers and industry. As challenges such as cybersecurity and complexity of operations increase, we are faced with requests to increase utility spending and must consider the adequacy of risk management strategies. Coordinating our efforts and co-working with others who share a common goal can help us manage this risk and minimize costs to stakeholders. This panel will discuss the benefits and plan to utilize our federal government's cybersecurity knowledge and coordination capabilities to ensure that we are adequately informed. 8:30 a.m. – 10:00 a.m.	<p><b>Session 6 ~ Indigenous Participation in Regulatory Decision Making</b></p> <p><b>Description:</b> In this session, the Canada Energy Regulator (CER) and the Canada Nuclear Safety Commission (CNSC) will discuss Indigenous participation in federal regulatory decision making processes.</p> <p>The CER will share its experiences over the last 18 months associated with the two Indigenous Advisory and Monitoring Committees (IAMCs) established by the federal government for the Enbridge Line 3 and TransMountain pipelines.
