

Background:

The Hepatitis C Community Clinic (HCCC), a free service, opened in early 2009, alongside the Needle Exchange in Christchurch, New Zealand to improve access to hepatitis C (HCV) care for people who inject drugs (PWID).

The employment of a social worker was considered essential as HCV was often accompanied by addiction, stigma, discrimination and psychosocial issues.

Results:

The social worker currently manages a case load of 193 clients. Recent data suggests 72.5% of our client base receive a social welfare benefit and 22% identify as Maori. Other determinants of health and well-being also affect our clients and these have been exacerbated by the major earthquakes experienced in Christchurch in 2010 and 2011. As well as managing their HCV journey, the role encompasses intensive support when required. In 2015 the clinic had a 95% first specialist appointment attendance rate. There has been an increase in clients on treatment, increase in referrals from GP's and treatment providers for extra support.

Conclusions:

The Hepatitis C Specialist Social Work Role has improved HCV outcomes for clients with a wide range of issues. The case management model within a multi-disciplinary team has facilitated the process of engagement, assessment and intervention and contributed to an increase in clients accessing treatment.
