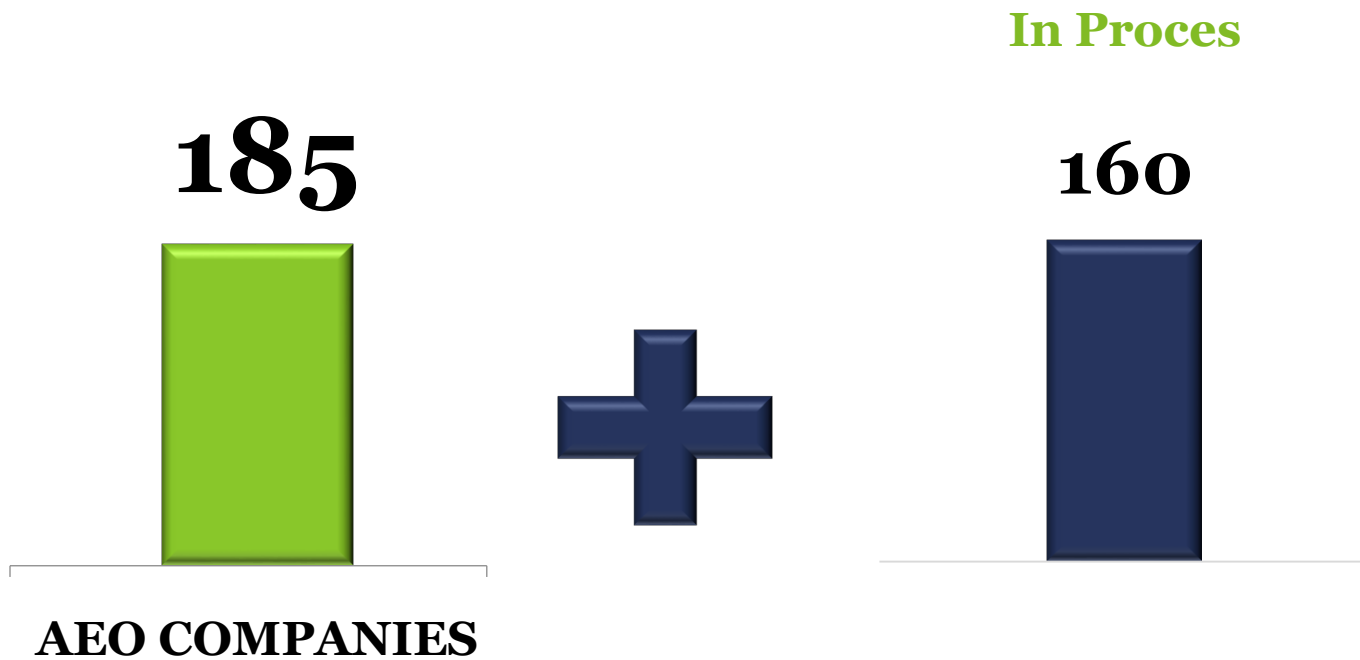

1. **24 Hours Clearance.**
2. **Assignment of a Supply Chain Security Specialist to the company**
3. **Express Clearance: Reduced number of physical inspections and examinations, as appropriate.**
4. **Reduced number of documentation and data requirements, as appropriate.**
5. **Properly identified and exclusive Customs Officers.**
6. **Coordination Control and Faster Lift.**
7. **Deferred payment of duties, fees and charges, as applicable; under the WTO Facilitation Agreement.**
8. **Use of general guarantees o Reduction of guarantees;**
9. **A single Customs declaration for all imports, or exports made in a given period; - Under the WTO Facilitation Agreement - and**
10. **Clearance of goods at AEO premises, at another place authorized by Customs. - Under the WTO Facilitation Agreemen.**
