TERMS AND CONDITIONS

These Terms and Conditions apply to your participation in and/or registration for the 2019 TCT | Transplantation & Cellular Therapy Meetings of ASBMT and CIBMTR (TCT Meetings), formerly the BMT Tandem Meetings, (also herein referred to as "event"), which are organized by the American Society for Blood and Marrow Transplantation and the Center for International Blood and Marrow Transplant Research (collectively the "Show Organizer"). Please carefully review the following Registration Policies along with the Legal Disclosures, Attendee Release Agreement and Conference Venue Disclaimer. You must agree to all of these policies and waivers within the registration process.

CANCELLATIONS and REFUNDS POLICY

- Cancellations must be sent in writing by January 15, 2019 to TCTMRegistration@conferencedirect.com. Your registration fee, less a \$75 administrative fee, will be refunded in the same form as the payment was made if cancellations are received by January 15, 2019. Registrations cancelled on or after January 16, 2019, will not be refunded. Any exceptions shall be at the sole discretion of the Show Organizer. There will be no refunds due to weather.

TRANSFERABILITY and BADGE REPLACEMENTS

- Registrations are transferable within your organization. Substitutions must be sent in writing by January 15, 2019. After January 15, 2019, substitutions will only be accepted on-site and will incur a \$50 administrative fee. Please email TCTMRegistration@conferencedirect.com to make these arrangements.

CHECK and WIRE TRANSFER POLICY

- Checks must be payable to "TCT Meetings" and be drawn in U.S. funds from a U.S. bank. To receive a specific conference rate, checks must be postmarked no later than the registration rate deadline or you will be charged the next registration rate and incur any additional fees. Therefore, if registered by October 12, 2018 checks must be postmarked no later than October 12, 2018 to receive the Early Registration Rate. If registered by January 22, 2019 checks must be postmarked no later than January 22, 2019 to receive the Standard Registration Rate. Please note all checks must be received by January 30, 2019. There will be a \$15 fee for all returned checks. Checks will not be accepted on-site.
- Wire transfers must also be received by January 30, 2019. The same check qualification process for specific conference rates applies to wire transfers as well. Please add \$25 for wire transfer fees.
