## Major Dermot Quinn Massachusetts State Police

Dermot Quinn is a Major with the Massachusetts State Police currently assigned as the Commanding Officer of the Criminal Information Section and the Commonwealth Fusion Center. Throughout his 29 year career, he has served in assignments in Field Services, Administrative Services, and for the past 18 years, in the Division of Investigative Services. Major Quinn attended the University of Massachusetts at Lowell where he received a Bachelor of Science and Master of Science in Criminal Justice and an MS in Mathematics (Computer Option).

As a Deputy Division Commander, Major Quinn has focused much effort on increasing the sharing of criminal information among law enforcement agencies not only in Massachusetts but across the New England region through the implementation of several regional crime databases and by partnering with the New England High Intensity Drug Trafficking Area program and the New England State Police Information Network. Major Quinn also oversees the anti-terrorism efforts of the Massachusetts State Police, which, among other criminal investigatory duties, maintains a strong presence on the Massachusetts JTTF.

Children Separated by Disaster - Sharon Hawa, National Center for Missing and Exploited Children / AH Castanet 4 Family reunification is not often indicated as a priority in the disaster planning cycle but when it comes to children it needs to be. Children who become separated from those who best understand their individual needs, can add to challenges. If not planned for or protected properly, these minors are susceptible to maltreatment, abuse and exploitation. NCMEC offers technical assistance to the disaster community to manage the task of reunifying children with their legal guardians.

# Optimizing 30,000 Sandy Volunteers With Crisis Cleanup - Aaron Titus, Church of Jesus Christ of Latter-day Saints DP Castanet 3

The presentation will explain the Mormon Helping Hands response to Hurricane Sandy and the Derecho storms, especially with respect to new technologies like a member damage report hot line, and Crisis Cleanup, which drastically improved efficiency in deploying volunteers and inter-agency coordination using Crisis Cleanup.

# Latest Drugs of Abuse - Dr. Ken Lavelle, Emergency Training and Consulting / H Bongo 1

As quickly as the FDA and DEA make certain emerging drugs illegal, "Street Chemists" are able to modify existing substances to stay ahead of the regulatory and law enforcement efforts. This program will review the latest drugs of abuse (including prescription drug abuse) and discuss appropriate treatment at both a BLS and ALS level. In addition, the newest effort to minimize overdose fatalities – intra-nasal naloxone – will be discussed by the speaker, who has spearheaded the effort to increase the availability of this potentially life-saving drug in both the civilian and emergency services community in New Jersey.

# "Lights, Camera, Action" - Train Like You Fight, Fight Like You Train - Steve Pawlak and James Munday, Port Authority of New York and New Jersey / P Bossa Nova 1 & 2

Are we training like we are going to fight or are we just exercising to check the box and get by? Is your agency ready for the next active shooter in a crowded venue? The next airplane crash? Or the next Mother Nature catastrophic event? Your answer is probably "NO". No one can say we are 100% ready. This presentation will cover how the Port Authority of New York and New Jersey Office of Emergency Management builds a comprehensive full scale exercise program based on the DHS HSEEP building block model which has worked to enhance preparedness training for both Port Authority as well as our external mutual aid partners.

# NJEMS Task Force - Mickey McCabe, Deb Bell, AtlantiCare R&R Tambora

This presentation will cover the roles and responsibilities of the New Jersey EMS Task Force and how it functions within the state. The presentation will cover pre-existing EMS plans for

Incidents of Significance, their development, and implementation and future planning efforts. We will also discuss the regional-based specialized EMS Task Force assets, their capabilities, and the request procedures for these assets. Discussion will also be held on previous task force deployments and lessons learned.

# Weather Ready Nation & NWS Decision Support Services for Super Bowl XVIII - Ross Dickman, National Weather Service; Dr. Dave Robinson, NJ State Climatologist / W Pageant

The NWS provided Decision Support Services for the safe conduct of the Super Bowl XLVIII and all of its associated events. The Super Bowl, a national event, occurred on February 2, 2014 at MetLife Stadium (MLS) in East Rutherford, New Jersey. This was the "first" outdoor cold weather Super Bowl. Through the Weather Ready Nation initiative, National Weather Service New York, NY coordinated the largest network of Decision Support Service Meteorologists since Hurricane Sandy to ensure the protection of life and property. This session will take a look at how NWS engaged its partners leading up to and during the Super Bowl.

# What's Going on in Your Community-Interactive Information Fred Campbell, READY Solutions / AH Castanet 4

Born out of Hurricane Sandy and Lessons Learned, GeoMapping provides for better Situational Awareness and a Common Operations Picture. Municipal Managers benefit – They see the "Big Picture". Emergency Managers benefit – They have a "Common Operating Picture".

Get Off the D\*\*n Beach: Effective Multi-platform Communications for First Responders during Crisis Situations - Richard Huff, Atlantic Highlands First Aid Squad DP Castanet 3 How EMS, OEMS and other officials respond before, during and after a crisis can significantly impact the fate of their constituents and perception of their organizations. Knowing how to craft a message and how to distribute it can be key to the outcome of the event. The class is targeted for anyone who may respond to a disaster, and who may find themselves having to help get the message out. Attendees will learn what to say and what not to say, how to deliver the message, how to get management buy-in ahead of time, and how to react when the message goes wrong. There will be a discussion of using traditional, online and social media to distribute messages.

EMS Planning and Response to Mass Shootings - Christopher Taylor, Cooper University Hospital / H Bongo 1

This presentation provides an historical review of active shooter incidents and a critique of the EMS response to them. It offers a "best practices" approach to planning for and responding to such events with focus on: mind-set, training, equipment, and tactics. It is meant to be a starting point for any provider or agency in their preparation for an active shooter incident in their community.

# Addressing Addiction Issues in Shelters - Megan Sullivan, NJDHS / $\stackrel{\textbf{P}}{\textbf{P}}$ Bossa Nova 1 & 2

This workshop will give a brief overview on the many addiction related issues that present in shelter settings. Participants will learn signs and symptoms of abuse of specific substances and understand the dangers of immediate detoxification of some drugs of abuse. Participants will also learn the NJDMHAS' GEMS system, in place for guest and emergency dosing of methadone in the community.

Chemical Release Pre-Planning Using ALOHA & MARPLOT: Not as Hard as You Think! - Brian Petuch, Merck

**R&R Tambora** MARPLOT and ALOHA are no-cost chemical release modeling programs provided by NOAA. Releases from fixed facility and transportation accidents can be modeled to show impact on surrounding populations, including helping with shelter-in-place options.

#### Using the Media as a Force Multiplier fro Emergency Management - Anthony Mangeri, American Military University / SP Mambo 3

The ability of emergency management to communicate their strategies and inform the public adequately during time of crisis is essential. Equally critical is the value of the media as a partner in providing guidance on preparedness, risk reduction strategies and securing the reputation of the emergency management organization. This workshop will introduce the notion of using the media as a strategic partner. We will look at the potential roles for the media in building the perception of emergency management programs before a disaster, working to promote the Whole Community approach to preparedness, and to assist with distribution of disaster recovery information.

# Winter's Hazards - Impacts of the Polar Vortex - Gary Conte & Joe Miketta, National Weather Service / W Pageant

Learn all about the polar vortex, the winter hazards it brings, and the impacts it causes. National Weather Service deterministic and probabilistic forecasts for and impacts of Extreme Cold, Low Wind Chills, Freezing Rain (Ice), Blizzards, and High Winds will be presented. Learn how you can use new experimental products such as the Graphical Hazardous Weather Outlook and Snowfall Probabilities to help you plan for and respond to a variety of winter weather emergencies.

# IMT Training: The Federal Perspective - Robert Ridgeway, FEMA / AH Bongo

The primary goal of the NIMS ICS All-Hazards Position Specific Training Program is to provide additional training that may be needed by personnel responsible for managing incidents of greater complexity than those typically encountered during routine operations. This training is designed to provide all-hazards competencies and behaviors for command, general staff and selected unit leader positions within a Type III or IV Incident Management Team (IMT) environment. This interactive presentation will discuss the development of the All hazards Position Specific training program, as well as its nationwide implementation.

#### Ports in a Storm: The Library as Community Disaster Recovery Center - Michele Stricker, NJ State Library DP Bossa Nova

When disaster strikes, where do you go? After Hurricane Sandy hit New Jersey in late October 2012, people went to their local library. Many community libraries were pressed into service as ad hoc Disaster Response Centers. Even though they may have sustained great damage to their own buildings, librarians rallied and were in the forefront of providing services and information to those in need, and respite from the storm.

# Resilient Individuals, Organizations and Communities: The Human Dimension - Dr. Joseph Napoli, Resiliency, LLC. H Castanet

Resiliency, resilience and resilient appear to be used everywhere for everything. But what is resiliency? What are the assets of resilient individuals? What is the necessary human infrastructure for organization resilience? What are the building blocks for a resilient community? How is resilience enhanced? How is a culture of resilience promoted? How are communities hardened to better withstand disasters? Participants in this breakout session will learn about the essential role of resiliency in the human dimension of disaster response and recovery and how resilience is necessary for people to bounce back, organizations to continue and communities to rebuild.

# Sheltering Guidelines for Children and Families - Nancy Gagliano, NJDCF / P Tambora

Emergency shelters and mass care facilities for families during a disaster should be well-designed, well-stocked, and appropriately staffed to promote the safety and security of infants and children. This presentation will offers general guidance, suggestions and ideas for shelters providing care to families with

children. This presentation is not intended to replace the actual experience and training that sheltering children and families require. Family friendly policies and practice, emotional wellbeing, child health and hygiene and an overview of supplies and nutrition will be covered. Additional information and resources will be shared.

Hurricane Sandy Waterway Debris Removal Project - Unprecedented - Tim Berkhimer, Dewberry / R&R Pageant Recovery of debris from waterways is wholly different than recovery of debris from land-based operations. Perhaps the most significant element of differentiation was the impact that environmental and historic preservation would ultimately play, and bring many additional State and Federal regulations into play during debris removal operations. Coordination with NJDEP identified numerous species of endangered and protected wildlife that make the southern region of the State a favorite stop-over point during their return trip north from warmer-winter climate areas. In this breakout learn what was involved after Superstorm Sandy debris removal with regard to waterway.

# GridEx II The NERC Grid Security Exercise - Tom Born, Atlantic City Electric / SP Carousel

On November 13th and 14th, The Electric Industry participated in GridEx2 to exercise the current readiness of the electricity industry to respond to a security incident. This presentation will provide an overview of the exercise and detail how PHI participated in it.

# Storm Surge 101 - Joseph Miketta and Gary Conte, National Weather Service / W Mambo

Storm surge was the major impact from Superstorm Sandy, responsible for significant loss of life and incredible property damage. Surveys show that most people think strong winds are the most dangerous hurricane threat, not storm surge. After Sandy, we know better. This breakout session will cover the key points and takeaways from the 8 hour training class on storm surge offered earlier this week. Stay ahead of the next storm, and the next storm surge, by attending this presentation, covering the latest techniques for understanding the storm surge threat.

# Alzheimer's and Emergency Response - Meredith Gordon, Alzheimer's Association / AH Bongo

This workshop will provide attendees with a working knowledge of Alzheimer's disease and related dementia's as it applies to the emergency response field. Topics covered in this presentation include: Disease basics and local statistics; Common behaviors; Emergency communication techniques; Dementia specific search & rescue tips; State specific dementia resources in planning and response.

Planning for Effective Use of Public Transportation during a No-Notice Mass Evacuation - Case Studies - Suhasini Nataragan & Tom Tran, Jacobs Engineering / DP Bossa Nova In case of a mass evacuation from large metropolitan areas, regional public transportation systems, especially passenger rail systems, are important assets to transport a large volume of people who have limited or no access to private vehicles. This presentation illustrates the concept of operations developed to support evacuees using public rail transit, if in operation. It also includes examples of support functions necessary for managing people leaving rail stations in the District of Columbia and arriving at rail stations in Northern Virginia and in Maryland. These support functions were part of the catastrophic preparedness in the National Capital Region.

#### Mass Care Standards of Care - Dennis Dura, NJDHS /

H Tambora New Jersey learned thorough the severe weather events of Irene and Sandy that while resources eventually flood in to the State from other parts of the country, we need to be able to establish levels of acceptable care in services provided across a spectrum of partners, considering ethical issues and demonstrating the benefit of agreed upon baseline services throughout New Jersey,

# Statewide Public Safety Broadband Network - Fred Scalera, NJ OHS&P / P Castanet

This network will be deployed in 3 locations within the state. In a few years, this will transform into the national Broadband network called First Net. The deployed system will be accessible to all Public safety personnel in those 3 areas and will be the first network operational of its kind in the nation.

# How to Say "No", Ceasing Emergency Response - Peter Dworsky, MONOC / R&R Pageant

One of the most difficult decisions for an Incident Commander or Commanding Officer is the determination to halt emergency response. It is the culture and nature of emergency responders to go into any environment in order to save the lives of those they serve, even if it means jeopardizing their own safety. We will look at best practices and model policies and discuss the risk-benefit and legal liabilities of a cessation in operations.

# Managing Communications for Large Scale Events - Jeff Doran and Rob Wright, Mutualink / SP Carousel

Emergency preparedness for large-scale events includes a comprehensive plan for intra-agency communication and interagency coordination. State cultural agencies are collaborating to strengthen emergency preparedness at the state level and foster preparedness at the local level.

This unclassified briefing will include a discussion on current chemical, biological, radiological and nuclear threats. Case studies, legal authorities, FBI response assets and threat credibility evaluation process will also be discussed.

# Wellness for the First Responder - Ronald Franceschini, Bacharach Institute for Rehabilitation / H Castanet

This breakout will provide attendees with the latest research in the mortality and morbity of first responders, including fire, police and EMS to guide strategies in maintaining good health while working in these stressful occupations.

# Emergency Management Leadership for Local Elected Officials - Timothy McDonough and Bill Dressel-League of Municipalities / P Tambora

Session will provide local leaders with an overview of important information that is vital in preparing for and responding to any type of emergency that their community may face. The curriculum will emphasize the role that executive leadership and elected officials play in preparing for, responding to, recovering from, and managing emergencies. Emphasis will be on their understanding of the role that the federal, state governments

play in resource management and identifying funding requirements.

This fire was the largest in Burlington County and unltimately reached 11 plus alarms. Representatives from the County and Deitz and Watson will be on hand to present the different phases of the emergency and unique issues that each presented.

# ESF #12 and Local Energy Assurance Planning - Stuart Wallace, Witt O'Briens / SP Carousel

Severe weather in recent years caused significant disruption of energy supplies across the State of New Jersey. Response and recovery for energy emergencies requires preparedness focused on improved communications and interactions with public and private stakeholders and more resilient and efficient energy infrastructure. Energy assurance plans (EAPs) build on existing emergency operations plans and ESF #12: Energy to implement this comprehensive approach. Experiences from major cities -Denver, Philadelphia, & Newark, NJ - and smaller communities Peoria, IL & Manhattan, KS – illustrate advantages and best practices for developing EAPs for New Jersey communities. In December 2011, the All Hazards Consortium (AHC) and Department of Homeland Security (DHS) Office of Infrastructure Protection facilitated a workshop, Multi-State Transit Coordination for Rapid Critical Infrastructure Restoration, focused on processes and protocols for the transit of mutual assistance.

# Tsunamis from Storms? Who Knew? - Joe Miketta, National Weather Service / W Mambo

On June 13th, 2013, a strong complex of thunderstorms moved through the region, producing wind damage and heavy rain. Later that afternoon, unusual wave conditions were reported along the Atlantic coast. It's believed that a meteorological tsunami occurred, tsunami-like waves produced by weather conditions. This event generated considerable public/media interest. Learn more about this event and how it occurred.

Including individuals with disabilities in the emergency planning process is the key to providing for the whole community and is increasingly a concept which needs to be understood on the planning level. Noah's Ark Institute recently completed a FEMA NJOEM passthrough grant: Including the Disability Community In Emergency Planniong Spacial Mapping Project. The results of this project will reveal the areas of disability density in the top four counties of New Jersey and provide insight into the planning needs of the community. This presentation is a report out and dissemination of the final results of this project.

# NJEMS Response to Super Storm Sandy - Henry Cortacans, UMDNJ / R&R Mambo

New Jersey's response to Hurricane Sandy was unprecedented in that this disaster affected the entire eastern seaboard with NJ as the epicenter. New Jersey's EMS system has prepared for years to respond to large scale events, however, this super storm would prove to challenge New Jersey's EMS response in an unparalleled manner. This session will detail the EMS response to this catastrophe, including the coordinated effort with other state and federal partners, which was instrumental to its overall response that undoubtedly saved lives.

#### **PREPAREDNESS**

#### Amateur Radio License Course & TEST

The Amateur Radio Service offers a unique mix of technology, public service, convenience and fun. Some hams enjoy communicating across the country and around the globe, making new friends over the airwaves. Others like to build and experiment with

electronics, experiencing cutting edge technologies. Some use their radios and skills during emergencies or disasters when all else fails. The goal of this course is to prepare students to take, and pass, the entry-level Amateur Radio (Technician) license examination. Course Materials provided will be from the American Radio Relay League (ARRL). The first day and a half will involve classroom instruction, with study assignments; the afternoon of the second day, attendees will take the ARRL/FCC VEC examination, and receive the results on-site.

The cost for the ARRL License Manual and to complete the ARRL/FCC VEC test is \$45.00; this fee is in addition to the NJEPA Conference Registration fee. \*Books will be sent to students prior to the class.

#### **Emergency Management Basic Workshop**

An eight hour introductory course for personnel who are new to the field of emergency management. Subject material will include New Jersey Emergency Management Laws and Directives, the Integrated Emergency Management System, the Role of the Emergency Management Coordinator, Training, Exercising Programs and Disaster Recovery. This course may be attended by all New Jersey personnel in the emergency management field.

#### **Disaster Logistics**

During a disaster jurisdictions may not have enough trained logisticians to execute effective logistics operations. The Disaster Logistics Training Program is a 5-hour, 4-course training designed to expand the logistics capacity and capability in local EOCs. Courses include: LOG 101– an introduction to the general principles of logistics and the practice of disaster logistics; LOG 200–explaining the resource management process; LOG 201 – explaining how to support staging operations from the EOC; LOG 202 – explaining how to support Point of Distribution operations from the EOC.

# Emergency Preparedness Response Course

This course is designed to prepare personnel to effectively respond to an all-hazards incident including those emanating from chemical, biological, radiological, nuclear, or highvield explosives (CBRNE) sources. This course also explains the current global threat of CBRNE use, the characteristics and effects of threat agents, principles of personal protection, agent detection, recognition and emergency treatment of agent exposure, and the principles of triage and decontamination of CBRNE agent casualties.

\*\* In addition to the conference fee, this course also has a fee of \$50.00 required for course management. \*\*

#### Mass Care/Emergency Assistance Planning and Operations

Prepare Mass Care Coordinators and their teams to develop Mass Care/Emergency Assistance plans to support and/or coordinate Mass Care disaster responses.

#### NJ EMS Task Force Status / Check-In Recorder Course

The purpose of this course is to provide personnel with an introduction to the role and responsibility of the Status / Check-In Recorder in a large scale operation. This course will cover responsibilities from mobilization to demobilization, including resource typing, tracking of resources, T-Cards, and assisting in demobilization planning.

This course will be open to providers who meet the following pre-requisites:

ICS 100, 200, 700, 800 CBRNE Awareness Hazmat Awareness and preferably EMS Response to Large Scale Incident Awareness Upon successful completion the student will receive a certificate of completion and Verification Card. The Verification card can be presented to a County OEM EMS Coordinator or designee at a County Staging Area as proof of knowledge that the individual has successfully completed the course and possesses the knowledge necessary to manage a Check-In Unit/Station. It will be up to the County OEM EMS Coordinator or incident management personnel as to who may fill this role in their operation.

#### NJ EMS Task Force Demobilization Unit Leader Course

The purpose of this course is to provide personnel with an introduction to the role and responsibility of the Demobilization Unit Leader in a large scale operation. This course will cover the importance of a formal demobilization, establishing the unit, preparing the demobilization plan, and other common responsibilities.

This course will be open to providers who meet the following pre-requisites:

ICS 100, 200, 700, 800 **CBRNE** Awareness **Hazmat Awareness** and preferably EMS Response to Large Scale **Incident Awareness** Upon successful completion the student will receive a certificate of completion and Verification Card. The Verification card can be presented to a County OEM EMS Coordinator or designee at a County Staging Area as proof of knowledge that the individual has successfully completed the course and possesses the knowledge necessary to a Demobilization Unit/Station. It will be up to the County OEM EMS Coordinator or incident management personnel as to who may fill this role in their operation.

#### **Multi Agency Coordination** System Course

MACS Course (IS701A or Equivalent)

This course introduces Multi Agency Coordination (MAC) system as described in the National Incident Management System (NIMS), and shows how these systems can be used to improve incident response on a Statewide or Regional basis. Lessons Learned from the NJ EMS MACS' use on recent events will be incorporated.

#### **NJ Fire Service Preparedness**

This course will inform attendees of the various State and County level Fire emergency resources and programs available to them. The Fire Resource Deployment Act along with the Fire Coordinators system will be explained and how to access the Fire Coordination system in their community. Fire Mutual Plans and agreements will be discussed. We will provide information on specialized Fire fighting equipment throughout the state and discuss recent large scale deployments.

#### Radioactive Contam Monitoring and Decon Strategies in the Event of a Radiological Dispersal Attack

The training session will address radiation monitoring and decontamination strategies in the event of a radiation or nuclear terrorism event. Emphasis will be on the proper use of instrumentation and alternative approaches to decontamination. It will address both tactical operations and population screening and decontamination.

#### Drug Impairment Identification for EMS

This presentation assist the emergency service person in recognizing the clinical indicators of drug impairment. They include readily recognizable signs from the eyes, pupils, blood pressure, pulse and other indicators.

#### Mental Health First Aid (Class 1)


Mental Health First Aid is an 8-hour course that teaches you how to help someone who is developing a mental health problem or experiencing a mental health crisis. The training helps you identify,

> understand, and respond to substance use disorders. \*\* This is the first offering of 2, of this 8-hour course. Students are only required to attend one

> signs of mental illnesses and 8-hour session.

#### G-270.4 Local Government Role in Disaster Recovery -

This workshop is designed for local government disaster recovery professionals to include elected officials. The workshop covers the roles, responsibilities, and major tasks of each team member during short- and longterm recovery. Participants learn the importance of recovery in the emergency management cycle, its role in the local community and the relationships between local government, non-profit agencies active in disaster and the community at large



during the process.

#### Medical Unit Leader Course

The purpose of this course is to provide EMS personnel with an introduction to the role and responsibility of the Medical Unit Leader in a large scale operation. This course will cover responsibilities from mobilization to demobilization, including planning and establishing the Medical Unit and Aid Stations, important principles of incident rehabilitation, risk assessment, managing non-urgent medical complaints of responders, and writing and ICS 206 Medical Plan and appropriate unit forms.

This course will be open to EMS providers who meet the following pre-requisites:

**EMT Basic or Paramedic** ICS 100, 200, 700, 800 **CBRNE** Awareness **Hazmat Awareness** 

and preferably EMS Response to Large Scale Incident Awareness.

Upon successful completion the student will receive a certificate of completion and Verification Card. The Verification card can be presented to a County OEM EMS Coordinator or designee at a County Staging Area as proof of knowledge that the individual has successfully completed the course and possesses the knowledge necessary to lead a Medical Unit. It will be up to the County OEM EMS Coordinator or incident management personnel as to who may fill this role in their operation.

#### NJ Highway Incident Traffic Safety Guidelines and Risk Management for Emergency Responders on Limited Access Highways

This course will cover the uniform operational guidelines to ensure safe operations and limit the liability risks by emergency responders dispatched to incidents on limited access highways in the State of New Jersey. These guidelines were formulated based on nationally recognized practices and procedures and input from representatives of those agencies listed under the State of New Jersey Highway

Incident Traffic Safety

endorsed by the New Jersey
Office of the
Attorney General.

#### Don't Overlook the PIO: How One Position Can Make Or Break an Organization

To be successful, organizations need to use media, marketing and social networks to build awareness for their services. Getting the word out about what organizations do for their communities is critical to their survival. This class will provide useful tools for participants to use at home and immediately increase their visibility. It will also outline the duties of a PIO, what skills are required, where the PIO fits in the hierarchy, and the pitfalls

of mishandling this key position. The class will include interactive elements to prepare attendees to become PIOs.

#### **Electrical Safety Awareness for Emergency Responders**

Emergency responders provide a valuable and necessary public protection service when they stand by scenes of electrical emergencies until we're able to respond. This presentation has been prepared to help emergency response personnel identify and report damage to electrical facilities during electrical emergencies. We will discuss power system damage that can occur during storms and traffic accidents. These situations can pose a significant danger to the public and the emergency workers. We will review rapid reporting of such problems is a key factor in restoring service and protecting the public. We will review what should be done when electrical facilities are involved in an emergency situation. What the primary function is until the utility responds is to set up a secured safety zone protecting the emergency workers, the public and protect exposures.

#### I-402 Incident Command for Executives

This program is an orientation for executives, administrators and policy makers. It provides a basic understanding of ICS for individuals who establish or implement policy but who are normally not part of the on-scene ICS organization. It also provides an introduction to the National Incident Management System, A nationwide template that enables all government, private sector, and non-governmental organizations to work together during emergency incidents. This program will be completed in approximately one 2-hour session.

#### CEU's - Pending

#### **Basic Hurrevac Course**

HURREVAC is a storm tracking and decision support tool for government emergency managers. The software is a product of the National Hurricane Program (NHP), a multi agency Federal partnership that provides products, training, and operational support to assist hurricane planning, preparedness, response, and

decision making at all levels of government. The software uses data from Hurricane Evacuation Studies (HES) along with real-time hurricane forecast data from the National Hurricane Center. This combination allows users to view hurricane forecast data both graphically and through detailed reports, and allows the software to calculate specific local evacuation decision times as hurricanes approach. The HURREVAC training course provides students with an overview of what the program is, how it works, and how to operate the program. By the end of the course, students will be familiar with the functions and tools within HURREVAC and how to access them.



#### Rapid Needs Assessment Workshop – G557

This course teaches the need

and development of plans/procedures for rapidly and efficiently collecting disaster intelligence immediately following a disaster.

#### 2014 PEOSHA Refreshers

This 4 hour lecture will cover all the areas needed to meet the states annual refresher guidelines for emergency services personnel. We will go over Bloodborne Pathogens, PEOSHA, HAZCOM, and the Respiratory Protection Act and Fit Testing. We will go over the ways and means of doing such training in house or having someone come to your place to do. Documentation of what needs to be in the work place and also in record form.

#### The New Situational Analysis Unit and Tool/Report

Following the Irene, Derecho, and Sandy responses, the NJOEM worked closely with its ESF Coordinators to develop a new situation analysis methodology. The procedure involves the use of individual "intake" forms, which are maintained and submitted from each of the State ESFs and also from the 21 County OEMs. These

Excel forms are made up of ESF and County essential elements of information. During significant activations, these forms will be gathered at specified times, one to two times daily, and compiled into an Excel workbook. This information is collated and analyzed by the SEOC's Situation Analysis Team, part of the SEOC Planning Section's Situation Unit. A summary document and list of priority objectives is then created and submitted to SEOC Command, and if present, the Governor and Cabinet. Once approved, priorities are used to develop a list of incident objectives (an ICS form 202) for the SEOC's next IAP. Speakers will review the process used to develop the forms and highlight how the process has been successfully used during the Sandy recovery efforts at the State's JFO, and subsequently in exercises and actual emergencies. It is hoped that the concepts developed by NJOEM for the State EOC can be utilized for any EOC seeking essential elements of information via ESFs and/or reporting jurisdictions.

#### RESPONSE

#### New Jersey Transit's Rail & Bus Safety for First Responders

The objective of this training is to provide to all first responders a basic overview of New Jersey Transit's Rail & Bus Emergency Response Procedures. The training starts with a Real World video of an actual passenger train emergency and a full response by Emergency Services, and will proceed into the Emergency Response Guidelines presentation. The following Subjects will be covered; brief history, railroad direction and system map, NJT Police and Emergency Services, connecting services, response agencies, ICS/ NIMS, general railroad safety awareness, Train Crews and Supervisors responsibilities, determining location, protecting your personnel,

stopping trains safely with hand signals, and many more safety related tips for operating on or near NJ TRANSIT property and creating a SOG for your agency. The afternoon portion of this class is off-site of the Hotel. Transportation will be provided. Students need to dress appropriately for weather

This is an 8 hour course.

#### Hazwoper Refresher

OSHA regulations require that anyone working on a hazardous waste remediation site or performing emergency clean ups for their company have training under 29 CFR 1910.120 - Hazardous Waste and Emergency Response regulations. Regardless of their level of training under these regulations, everyone is required to take an annual refresher program. This course will satisfy those requirements. This course will provide case study workshops on emergency response activities, incident command system overview

and health & safety program development. CEU's - Pending

#### FEMA NIMS All-Hazards Strike Team/Task Force Leader

This is the FEMA NIMS All-Hazards Strike Team/Task Force Leader Training Program. Upon completion of this course, students will demonstrate, through exercises and a final exam, the capability to perform the duties and responsibilities of an effective Strike Team / Task Force Leader. Target audience members may have little or no actual experience as a member of an AHIMT. The audience may include participants from a variety of agencies and functional disciplines, including fire service, law enforcement, emergency management, public works departments, as well as public health organizations, medical emergency teams, and hospitals.

CEU's - Pending

#### Swift Water Awareness: Water Rescue For The First Responder Water Rescue for the First Responder addresses the need for water search and rescue, scene safety, assessment and management, activation of the emergency response system, training and resources

needed to perform water operations, and rescue versus recovery operations. The course contents meet NFPA 1670 Standards on Operations and Training for **Technical Rescue Incidents** - Water Search and Rescue - Awareness Level. A goal of the course is to provide essential water safety information to the first



#### NFPA 1584: Firefighter Rehab and Medical Monitoring

The new IAFC Firefighter Rehabilitation and Medical Monitoring Program, jointly developed and sponsored by Masimo and the IAFC, addresses vital occupational health and safety hazards for firefighters to meet a

previously unmet need without draining department resources. The program offers free on site and online training, educational resources and materials, development tools for standard operating procedures, guidance, and support to help fire departments implement and comply with NFPA 1584 required standards.

#### ICS Forms and Incident Action Plan Development

This program will focus on the use of the Incident Command System (ICS) Forms in accordance with the National Incident Management System (NIMS). This program will include a Fundamental review for Command, Command Staff, and General Staff Roles and Responsibilities. Through active participation those attending the course will work through the various and most commonly used forms in the Incident Command System. Those in attendance will develop through various activities and tabletop activities Incident/Event Action Plans (IAP's) for operational periods. Participants will also work through the Planning Cycle and the Planning "P". Those in attendance will be given the opportunity to work in an All Hazards



model between Police, Fire, EMS, Emergency Management, Public Health, and Hospital Staff. Target audience are those first responder's who based on roles and responsibilities during an incident may be responsible for creating ICS Forms as part of current incident documentation or the development of an Incident Action Plan. This is an 8 hour course.

#### **Elevator Rescue and Emergencies**

Emergency personnel with inadequate training in responding to stalled elevators are exposed to an increased risk of injury and death to both the victims and themselves. Learn how to safely and effectively remove passengers from stalled elevators as well as basic elevator procedures. Topics include nomenclature, safety, how an elevator functions, construction, elevator safety devices, possible equipment needed for rescues, initial response steps, lock-out/tag-out procedures, elevator doors, use of hoist way door keys, poling, firemen service (phase I/phase II) and manually lowering a hydraulic elevator.

This is a four hour course.

#### **Hazwoper Supervisor Training**

OSHA regulations require that anyone supervising and working on a hazardous waste remediation site or supervising emergency clean ups for their company have training under 29 CFR 1910.120 – Hazardous Waste and Emergency Response regulations. Prior to assuming supervisory control on a Hazwoper covered work site, that person is required to take an 8-hour supervisory training program. This course will meet that requirement. This course will provide workshops on management and supervisory development through case study, presentations and role playing.
