GEORGIA BUILDING AUTHORITY STATE GOVERNMENT COMPLEX **CAPITOL HILL Public Parking Map**

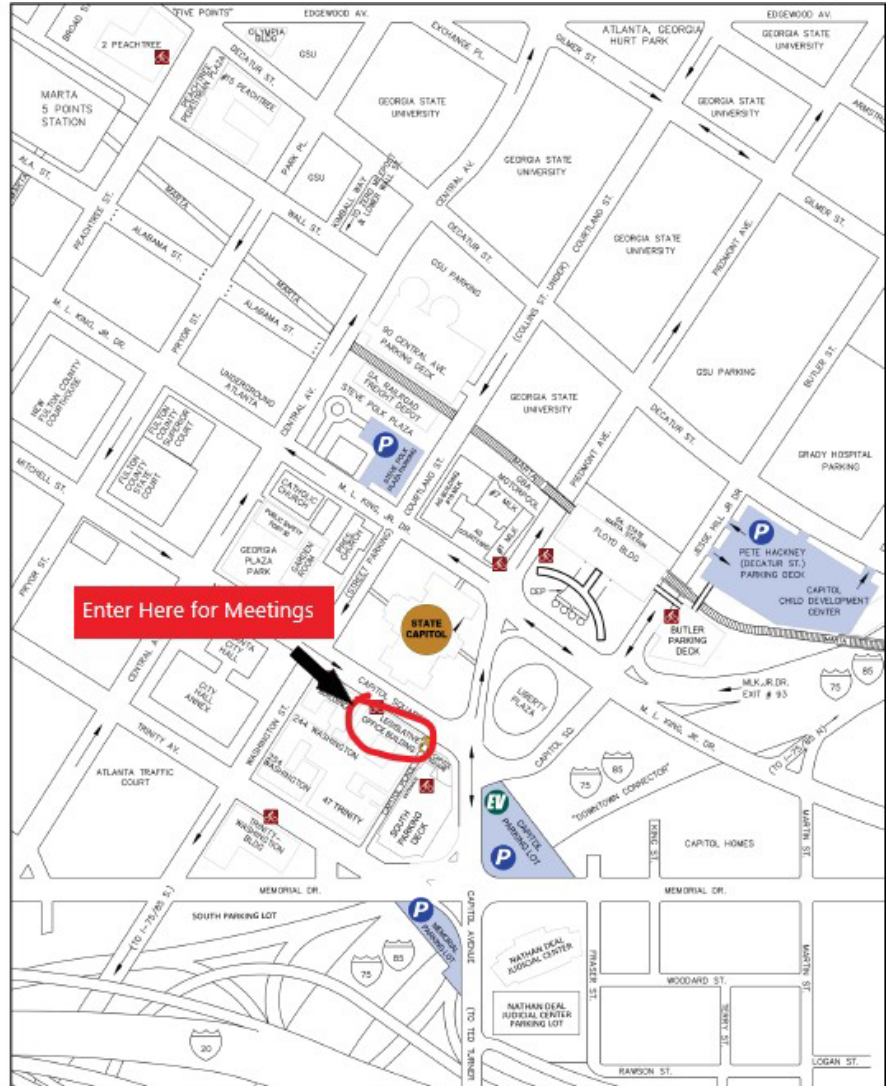
