



102 Easy to Diagnose but Hard to Treat Skin Conditions in Primary Care

Clinicians and patients can become VERY frustrated by treatment challenges for common skin complaints. Patients often believe skin conditions should be a simple cure and wonder, "Why can't you just fix it?" Understanding the evidence and exploring clinical pearls from experts can be the key to successful treatment of recalcitrant and chronic skin diseases such as eczema, warts, molluscum, seborrheic dermatitis, and more.

104 Update on Osteoporosis and Fracture Prevention Strategies

This session provides information regarding the screening and treatment of women and men at risk for fracture based on bone densitometry and their 10-year fracture risk using the FRAX calculation. Pharmacologic therapies will be reviewed, including their risks and benefits. Current controversies in management will be discussed, including long-term use of bisphosphonates, use of drug holidays, and rare adverse events including osteonecrosis of the jaw and atypical subtrochanteric femur fractures. New concerns about discontinuation of rank ligand inhibitors and the rapid increase in multiple vertebral fractures will be reviewed. Case studies will be used to provide real clinical scenarios.

105 Acute/Emergency Care: Putting Together the Puzzle of Shock: A Hemodynamic, Case Study Approach

When a patient is in shock, it's crucial to be able to recognize the type of shock and manage it appropriately to optimize patient outcomes. This session uses a case study approach to put the pieces together in recognizing the hemodynamic parameters of distributive, hypovolemic, obstructive, and cardiogenic shock states and identifying an evidence-based approach to managing these conditions.

111 Acute/Emergency Care: OSA and Hypoventilation Syndrome in the ICU: Are We Sleepwalking into Disaster?

The features of OSA/HS include obesity, alveolar hypoventilation, and sleep-disordered breathing. OSA/HS is often unrecognized with delayed treatment, resulting in erythrocytosis, pulmonary hypertension, atrial fibrillation, stroke, and right heart failure. The most common reason for hospitalization is dyspnea, which is likely to require ICU care and mechanical ventilation, often without identifying the reason for the failing cardiopulmonary state. When compared with eucapnic obese hospitalized patients, OSA/HS patients require more ICU admissions (40% vs. 26%) and have an increased mortality rate (23% vs. 9%). The goal of this session is to familiarize attendees with the physical, clinical, and social features of this syndrome. These patients are often unstable and require interventions such as NPPV, endotracheal intubation with ventilation, and tracheostomy, as well as correction of acid-base imbalance, hemodynamic support, and therapeutic phlebotomy.

112 Human Trafficking: Effective Clinician Response in the Healthcare Setting

An estimated 87% of rescued trafficking victims had encounter(s) with a healthcare provider during captivity in which they were not recognized as victims, missing opportunity for rescue and improved health outcomes. Nurses are critical front-line responders in the fight against trafficking of persons, who can present in any clinical setting. This presentation will equip nursing professionals to identify and intervene on behalf of potential victims. 201 Cardiodiabetes: The New Focus for Effective Type 2 Diabetes Management

Cervical cancer screening has changed significantly in recent years with less frequent Pap testing and the addition of HPV testing. This session reviews the appropriate use of Pap testing, the rationale for HPV testing along with the Pap (co-testing) in women age 30 and older, and an introduction to the use of HPV testing as a primary screen (standalone test) in women age 25 and older. There will be an introduction to the role of HPV 16 in anal and oropharyngeal cancer and review of current screening guidelines for anal and oropharyngeal cancer, as well as a discussion of counseling in the age of less frequent cervical screening and HPV testing.
