





# Importance of Customs Brokers in AEO Programme?



**Customs Brokers**: Who is licensed by the local Customs, after passing an examination that covers a broad range of knowledge including Customs law, Customs classification, Customs tariff schedule, import and export regulations, shipping procedures, trade documentation, etc

**Customs Brokers:** Act as intermediaries between traders and Customs in the clearance process. There are several practices in terms of regulatory/licensing requirements, roles and responsibilities, fees and charges, cooperation mechanism between Customs and brokers.

- Licensed Customs Experts: 6,352
  - persons




# Thai Customs' AEO Authorization Process





### AEO Programme in Thailand Benefits: AEO Customs Broker (continue)



### AEO Programme in Thailand Duties of AEO Customs Broker

- strictly comply with the customs law and other laws pertaining Customs, notifications and regulations prescribed by Customs Department, relevant regulations
- undertake Customs procedure in clearance of goods with transparent manner
- submit, within five months after the date of closing account of juristic person, a copy of the financial statement to the Customs department in every accounting year.
- perform their task in clearance of goods in skillful and professional manner

### AEO Programme in Thailand Duties of AEO Customs Broker

- their declarations shall be stamped or clearly written in block letters with red color at the top right of the original declaration and all duplicated copies with the following words "the importers and exporters with "AEO status"
- Customs brokers with AEO status have to refer the AEO reference number in each of goods items (in the export/import declaration detail)
- implement the security systems and risk assessment for security measures within the workplace

 cooperate and facilitate the competent officers' operation in examining the workplace

### AEO Programme in Thailand Liabilities of AEO Customs Broker



The Customs brokers with AEO status shall be liable to any action, done by their workers or employees or Customs expert(s), who act on behalf unless they can prove that they do not have involvement with such acts.



The Customs brokers with AEO status shall have obligation in paying Customs debt to the department as prescribed in the bond with security contract made with the Department.
