



In December 2002, President George W. Bush announced a national plan for smallpox vaccinations in order to be prepared in the event of a terrorist attack utilizing the biological agent. NJ was required to submit a statewide plan to the CDC for review. The first step of the plan was to vaccinate 2 teams. The Public Health Response Team is comprised of state and local public health workers and select law enforcement officers who will be responsible for investigating possible or confirmed cases of smallpox. The Hospital Health Care Response Teams are comprised of clinicians and support staff that will be responsible for treating initial victims of smallpox. The presentation will give an overview of how the NJ Department of Health and Human Services and the Atlantic County Health Dept are implementing the state and national vaccination plan.
