

SCHEDULE OF EVENTS

Join us as we welcome Superintendent Warren J. Riley, New Orleans Police Department and Major John Hunt, New Jersey State Police. Superintendent Riley and Major Hunt will share with us their insight from the Katrina response and recovery efforts, Operation LEAD and the aftermath of Katrina.

Operation LEAD: New Jersey's part in the Hurricane Katrina Recovery

As a result of the catastrophic effects of Hurricane Katrina upon the City of New Orleans, New Jersey, as a participating member of EMAC (Emergency Management Assistance Compact), deployed personnel and emergency equipment to render aid in the region. The mission, dubbed Operation "LEAD" (Louisiana Emergency Assistance Deployment), was organized and directed by the New Jersey Office of Emergency Management. More than 600 professionals from across New Jersey, including local and state law enforcement officers, medical support personnel, decontamination personnel, hazardous material teams, swift water rescue teams and fire fighters responded.

Operation LEAD included the creation of "Camp New Jersey," essentially a self-contained police department that led the law enforcement and other emergency services for New Orleans' Second, Third and Sixth Police Districts and surrounding regions, during the deployment.

Beginning on September 3rd and ending on October 11th, the operation basically consisted of three massive task force strength deployments of almost 200 personnel and emergency equipment. Each of the three task forces spent approximately two weeks in the New Orleans region conducting missions which included: District Patrol, Force Protection, Night Operations, Investigating unanswered 9-1-1 calls, House to House Searches, Decontamination Operations, Delivering Humanitarian Aid and Intelligence Operations.

As a result of Operation LEAD, New Jersey essentially redefined the way EMAC requests are conducted. New Jersey personnel were able to search almost 8,000 houses, rescued 67 people and 267 animals, identified and rendered aid to 174 persons who remained sheltered in their homes, assisted in the recovery of 115 bodies, conducted close to 9,000 decontaminations of people and equipment, rendered first aid to over 100 people and conducted more than 50 force protection details.

New Jersey's emergency aid to New Orleans was truly unique as Operation LEAD personnel were able to conduct their missions without drawing on already over-tasked Louisiana resources. "Camp New Jersey" was completely self-sufficient; all logistical, medical and technological requirements were handled internally. Therefore, beleaguered Louisiana emergency services were able to utilize New Jersey's available assets without having to further deplete their logistical resources (food, shelter, medical, etc.)



WARREN J. RILEY, Superintendent, New Orleans Police Department

Warren J. Riley, Superintendent of Police, New Orleans, Louisiana. Superintendent Riley is a 24-year veteran of the New Orleans Police Department. He holds a Master of Arts Degree in Criminal Justice, A Bachelorof Science Degree in Criminal Justice from Southern University of New Orleans and an Associate of Arts degree in Criminal Justice from Delgado University of New Orleans. He has attended the Senior Management Institute for Police Executives at Harvard's Kennedy School of Government, as well as many other courses in advanced Police administration and management.

Superintendent Riley is involved in many professional organizations and community groups such as: the Police Executive Research Forum (PERF), the International Association of Chiefs of Police (IACP), The National Organization of Black Law Enforcement Executives (NOBLE), Criminal Justice Advisor to the Louisiana University Violence Intervention Team, Vice President of the High Intensity Drug Trafficking Area (HIDTA), and a member of the State of Louisiana Drug Policy Board.



JOHN HUNT, Major, New Jersey State Police

Major John D. Hunt is the Commanding Officer of the New Jersey State Police Emergency Management Section within the Homeland Security Branch. In addition to administration of a \$30+ million budget, as Deputy Director of the New Jersey Office of Emergency Management, he is responsible for monitoring and allocating all funding related to the State Radiological Response Plan and 15 other federally funded programs. Major Hunt is directly responsible for the mitigation, preparedness, response, and recovery processes for the 21 counties and 566 municipalities within the State.

Most recently, Major Hunt was appointed as the Task Force Commander for New Jersey's Hurricane Katrina relief response to New Orleans. Operation LEAD (Louisiana Emergency Assistance Deployment) consisted of New Jersey law enforcement personnel, fire services, search and rescue personnel, emergency amedical technicians and a Salvation Army team. The Task Force was designed utilizing NIMS (National Incident Management System) principles and structured to be a completely self-sustained entity. New Jersey's Katrina relief deployment redefined the way states respond to EMAC (Emergency Management Assistance Compact) requests throughout the country.

Alphabet Soup - NIMS, NRP, TCL, ETC.

Thursday, 1:00 - Mambo. Tom Balint -Office of the Attorney General - New Jersey.

A look at NIMS, NRP, TCL, UTL, and other federal initiative requirements for 2006. A review of the federal capabilities based planning: the latest guidance; documents; and ideas for meeting current and future requirements. Updates to NIMS and the NRP (including the Catastrophic Incident Supplement); post-Katrina plan reviews; target capabilities and capabilities based planning; along with the latest grant guidance will be discussed and reviewed. The seven national priorities will be highlighted. DP

Animals in Disaster-The Snowball Effect

Friday, 11:00 - Salon 7/9. Holly Chmil-New Jersey Department of Agriculture.

Understand the lessons that Snowball taught us in Katrina. Learn how and why your county needs to put the CART before the horse (and other animals in your county) to be prepared to handle animal issues in disasters. R&R

Avian Flu - Impact and Local Response Capabilities

Thursday, 1:00 - Carousel. Peter N. Wenger, MD, Associate Professor of Pediatrics, Associate Professor of Preventive Medicine and Community Health, Assistant Professor in the School of UMDNJ Public Health; Phyllis Worrell, MICP, Emergency Management Coordinator, Virtual Health.

This session will address the medical and epidemiological aspects of avian flu which includes the epidemiology and history of the disease, prevention and treatment. It will include pertininent issues concerning the nature of influenza disease cycles both pandemic (shift variants) as well as interval epidemic (drift variants) events. It will also review local response capabilities focusing on hospital response and its impact on the community as a whole. R&R

BCC Public Center for Public Health Preparedness Simulation Lab

Friday, 9:00 - Carousel. Joy Spellman, Director-Center for Public Health Preparedness Burlington County College.

The community is the "patient" in public health practice. In these times of threats, both natural and man made, the use of simulation technology assists both the public health work force and first respondents in sharpening their clinical skills as well as their critical thinking abilities. Human patient simulators make it possible to customize training to meet the needs of specific groups. Desktop simulation clearly illustrates the importance of incident command training in a safe, controlled environment. DP

Cities Readiness Initiative

Thursday, 3:30 - Castanet. Moderator: Bob Gogats, Burlington County Health Department Panel: Repreentatives from several New Jersey communities.

A panel discussion of Federal, State and County health officials will discuss the new Cities Readiness Initiative. The Cities Readiness Initiative (CRI) is a pilot program to aid cities in increasing their capacity to deliver medicines and medical supplies during a large-scale public health emergency such as a bio-terrorism attack or a nuclear accident. It will enable cities to deliver medicines and medical supplies

to their populations within a timeframe that will make an appreciable health difference in the event of a bio-terrorism attack. CRI is needed to enhance preparedness at all levels of government and to provide a consistent nationwide approach at all levels of government to prepare for, respond to, and recover from a large-scale public health emergency. Multiple agencies are engaged in CRI to ensure coordination of response at Federal, State and local levels.

Delaware Bay Area Contingency Plan

Thursday, 3:30 - Bossa Nova. Gerald Conrad, United States Coast Guard.

The Area Contingency Plan for Sector Delaware Bay is a blueprint that is designed to ensure that the initial actions taken in response to a hazardous substance release, oil spill, radiological or biological incident that occurs in the maritime environment is effectively managed from the start. The plan covers the coastal areas of New Jersey from approximately Manasquan south to Cape May and from Trenton south to Cape May. P&P


Developing and Maintaining an Effective Staging Area

Thursday, 3:30 - Pageant. Keith White-Florida Power & Light. An effective staging site plan is critical to many organization's ability to respond and remotely support emergencies, from natural disasters to terrorism. Our presentor will outline the thought-process needed in developing an effective plan. This plan will review site selection, layout, safety, traffic-flow, logistics, vendors and staffing. In addition he will review training, execution and the maintenance required to ensure that your plan will be ready when needed. This session is not just for utilities, and will benefit any organization that may be called upon to remotely stage emergency personnel and equipment resources.

Disaster Mental Health Consequence Management - Psychological First Aid (PFA)

Thursday, 3:30 - Carousel. Steven Crimando, MA, BCETS New Jersey Department of Health and Senior Services.

Psychological First Aid (PFA) is a practical, frontline behavioral health intervention designed to limit the emotional distress experienced by the victims, survivors, and witnesses of disasters and other traumatic events. PFA is one of the few psychological interventions that has received universal support from the academic and research communities. PFA is an evidenced-informed skill set that can be used by healthcare providers, first responders, leaders and managers of disaster operations during and immediately following a disaster or act of terrorism. This Psychological First Aid awareness presentation introduces the key concepts of psychological first aid, its appropriate uses, and core skill set that can be used by both professional and paraprofessional disaster responders to help individuals, families, communities and businesses deal with the emotional aftermath of disasters, terrorism, and other traumatic events. R&R

SESSION DESCRIPTIONS

Effective Stress Management

Friday, 9:00 - Salon 7/9 Sally Blakely-Komar-LCSW-Personal Wellness Therapy and Lou Mascioli-New Jersey Disaster Critical Incident Stress Response - Office of Attorney General.

This presentation will focus on the importance of establishing an effective stress management program for the first responder. The presenter's have extensive experience in the clinical and emergency management field. They will address signs of stress and the benefits of clinical care interventions. Clinical terminology, past practices, lessons learned from Hurricane Katrina and 911 will be explored. Available services to New Jersey first responders will be presented. R&R

Emergency Management Assistance Compact (EMAC) Process

Thursday, 8:45 - Carousel. Howie Butt and Joe Geleta, Support Services Unit, New Jersey Office of Emegency Management.

EMAC, the Emergency Management Assistance Compact, is a congressionally ratified organization that provides form and structure to interstate mutual aid. Through EMAC, a disaster impacted state can request and receive assistance from other member states quickly and efficiently, resolving two key issues upfront: liability and reimbursement. Familiarize yourself with how to efficiently implement EMAC. P&P

Fasten Your Seatbelt: Fasten All Your Seatbelts!

Friday, 9:00 - Salon 3/4. Hurricane Hunter flight crew member-Major Robert Kraus. Members of the flight crew from one of the Hurricane Hunter flights into Hurricane Wilma will share their experience. Hurricane Wilma entered the record books in October 2005 as having the lowest central pressure of any Atlantic hurricane at 882 mb, beating Hurricane Gilbert in 1988 with 888 mb. At one stage a category 5 storm, Wilma produced well over 60 inches of rain as it moved across the Yucatan Peninsula, then turned northeastward and eventually made landfall in Florida as a category 3 storm. W

Firewise Communities

Friday, 11:00 - Pageant. Greg McLaughlin, James Petrini and Mike Drake - NJ Forest Fire Service.

Forest fire experts and skilled nurserymen will discuss how individuals and communities can protect themselves and minimize loss from wildfire using simple techniques such as Firewise Landscaping and Creation of Defensible Space. Topics that will be discussed include: Plant species selection; Landscape maintenance; Creation of defensible or survivable space; Forest Management Techniques and Methods for Community Protection; Defining "Zones of Protection"; and Hazard Mitigation Techniques. Interactive media will be utilized and time will be allotted for a question and answer period. Other topics to be discussed included funding opportunities for creation of defensible space. AH

Introduction to the Emergency Health Powers Act

Friday, 11:00 - Carousel. Karen Pappas, New Jersey Office of Public Health Preparedness. Become familiar with the legislation that recognizes the need to: balance common good with individual civil liberties; the duty to act with fairness and tolerance towards individuals and groups; the need to effectively prevent, detect, manage and contain emergency health threats without unduly interfering with civil rights and liberties.

Katrina, Rita and Wilma - Oh My!

Thursday, 3:30 - Mambo. Richard Pasch, Hurricane Specialist, National Hurricane Center, Miami, Florida; James Eberwine, Senior Forecaster, National Weather Service, Mt. Holly, NJ.

The 2005 Atlantic Basin Hurricane Season is one for the record books, and will be forever etched in our nation's memory. Dr. Richard Pasch, Hurricane Specialist from the National Hurricane Center in Miami, FL and James Eberwine, Senior Forecaster from the local National Weather Service office in Mount Holly, NJ will review the more significant aspects of the 2005 hurricane season. They will also put the season in a historical perspective, and will provide insight into what future hurricane seasons may look like, and how we should prepare to deal with hurricanes. W

Lessons Learned from 2005 Hurricane Season - A Utilities Perspective Thursday, 8:45 - Castanet. John Shaner (Allegheny

Power) and Mike Caffrey (Emergency Preparedness Partnerships Consultant and formerly of Conectiv).

As members of the Mid-Atlantic Mutual Assistance (MAMA) group, our presenters are veterans of responding to emergencies. MAMA consists of sixteen (16) electric utilities in the Mid-Atlantic region which last year responded to Hurricane's Katrina, Rita and Wilma. In addition to multi-state coordination and mobilization, John and Mike will lead a panel discussion on issues such as safety, communications, immunizations, housing, fuel and personnel change-out. They will also discuss interaction with other mutual assistance groups, as well as regulatory updates. R&R

New Jersey Emergency Preparedness Information Network NJEPInet Friday, 9:00 - Salon 5/6. Bruce Harrison, New Jersey Office of Attorney General.

- Information Sharing and Collaboration - In an effort to provide the New Jersey Homeland Security community with the ability to more effectively plan for, respond to, and recover from made-made and natural disasters, the State has embarked on an aggressive initiative know as the Emergency Preparedness Information Network (EPINet). Through the development of EPINet, a unified Geospatial Enterprise Architecture (GEA) will evolve, supporting information sharing and integration across all levels of government. The framework that supports EPINet utilizes a Service Oriented Architecture (SOA) that follows the "build it once - use it many times" philosophy of the National Spatial Data Infrastructure (NSDI). Through the development of EPINet, New Jersey is positioning itself to not only support the needs of the homeland security community but better support the overall business of government. A key to realizing EPINet has been the establishment of a sustainable set of infrastructure and policies through the development of strategic partnerships with local government. P&P

NJ National Guard Support Capabilities for NJ Emergency Responders Thursday, 8:45 - Pageant. *Jeffrey Pierson, USA BGen.* (Ret.).

The NJNG will provide information to the Emergency Management community regarding the support available to them from the NG. The program will cover an overview of Military Support to Civil Authorities, National Guard Task Force Support, Counter-Drug Team Briefing and Civil Support Team (CST) Briefing.

Our Katrina - Just How Bad Could It Be

Thursday, 8:45 - Bossa Nova. Gary Szatkowski, National Weather Service, Mt. Holly, NJ and Mike Wyllie, National Weather Service, Upton, NY. The challenge associated with a very high impact, low frequency event like Hurricane Katrina brings out the best (and occasionally the worst) in people. You've seen the remarks from some that they had no idea it could ever be this bad. Those who refuse to learn from history are doomed to repeat it. National Weather Service personnel from the Mount Holly, NJ and Upton, NY weather offices will present worst-case weather scenarios, to help frame the planning and preparedness activities for your area. Whatever else may happen, you will be able to say that you saw it coming. AH

Planning for Security Threats to Critical Infrastructure

Thursday, 1:00 - Castanet. Panelists: James E. Benton, Executive Director, New Jersey Petroleum Council; Hal Bozarth, Executive Director, Chemical Industry Council of New Jersey; James P. Giuliano, Director, Division of Reliability and Security, New Jersey Board of Public Utilities. Moderator: Fred J. Abbate, President and CEO, New Jersey Utilities Association.

What specific lessons have we learned about protecting our vital energy and chemical infrastructure from the 9/11 attacks on America and those that have occurred in Britain, Spain and other countries? Are we still as prepared as we should be, or have our efforts been flagging with time? What threats still exist and how have the professionals in these industries and in government been working to prevent them and also respond to them? This panel will address these and related questions that continue to be of great strategic importance to every citizen in our state and region. P&P

School Emergency and Crisis Management Planning using Geospatial Technology

An overview of the use of Geograhic Infomation Systems software in state of the art emergency management and preparedness planning for our educational facilities. Utilization of technology that is the core to the 3rd largest growing job market: Geospatial Technology and Remote Sensing, is quickly being recognized as a Best Practice in Emergency Management. Although focused on schools in this presentation, its use is becoming a primary function at most EOC's across the country. "A picture is worth a thousand words.....but GIS is worth a thousand pictures when it comes to Emergency Management".

Surfing the Internet for Weather Information

Finding great weather information on the Internet isn't hard, but keeping track of it all and keeping up with the latest changes can be a challenge. Let James Eberwine, Senior Forecaster at the National Weather Service office in Mount Holly, NJ (and one of the office's most prolific creators of Internet bookmarks) guide you through his list of favorite weather bookmarks. You'll know which sites you need to be aware of and when you'll need to use them. W

The Dirty Bomb - Preparation & Response to Radiological Hazards

Friday, 11:00 - Salon 5/6. Lt. Todd Biebel & Sergeant First Class Tom Scardino, Radiological Emergency Response Planning & Technical Unit. NJOEM.

This session will identify radiological hazards in New Jersey and provide insight on preparedness measures and response considerations for first responders. They will discuss the two fixed nuclear generation sites in NJ, as well as the current threat of terrorism with a radiation dispersion device. Planning procedures for nuclear hazards that can be applied to all hazards will be discussed and attendees will be provided with information on radiation dispersion devices and improvised nuclear device interdiction efforts.


The Media's Role During Major Weather Events - Local Perspective

Kathy Orr will explore the role of the local media during major weather events. The focus will be on lessons learned in a post-Katrina environment. Issues will be covered dealing both with pre-event and post-event media coverage and responsibilities. W

The Role of Insurance in Disaster Response

Thursday, 1:00 - Pageant. Richard Fatzynytz, CPCU, CHFC and Greg McKenna, State Farm Insurance Companies
This session will discuss the role that insurance plays in disaster recovery and the importance of mitigation to prevent and/or minimize losses. A panel of insurance experts will give easy to understand explanations of coverages available under most automobile, homeowners and commercial insurance policies and how these coverages work. The panel will also discuss the claim process, how insurance companies react after a disaster, and why good interaction with emergency managers and disaster response personnel is critical in helping disaster victims' piece their lives back together as quickly as possible. 





Communication Disasters & Communications Interoperability -Revisited (M) LT John Kratzer, New Jersey State Police Communications Bureau; Other Participants - This (4) hour session will include presentations on: 1. Critical Communications During Disasters, covering radio problems encountered during disasters, incident command, the latest technology, interoperability and possible solutions. 2. Emergency Mass Notification Systems a brief overview of the different means of notifying the public during emergencies with a demonstration and discussion involving the background, system selection process, education, implementation and challenges of the NJSP Reverse-911 System. 3. Providing Interoperability Solutions an overview of interoperability issues, technology, goals and what is being done in New Jersey to address the issues. 4. Panel Discussion on Critical Issues in Public Safety Communications. The panel will consist of five to seven experts in the field of Public Safety Communications addressing interoperability, radio interference, licensing issues, the 700 MHz and 800 MHz radio spectrum, rebanding, and lessons learned during the Katrina response.

Emergency Preparedness Information Network / EPINet (M) Lt. Steve Hoptay and Tom Rafferty, New Jersey State Police Office of Emergency Management - The purpose of the Emergency Preparedness Information Network (EPInet) is to provide law enforcement and emergency response communities with capabilities to support the sharing and intergration of critical information required to make more timely and informed decisions about domestic preparedness and response. In November 2005, the State reached out to various stakeholders in all levels of government to ask for guidance on how the network should be developed. This four hour session will be a chance for you to see progress that has been made and to provide feedback and what work still needs to be done to make the network function at its highest level.

Creating & Maintaining a Hospital Decon Team (P) Savitria Chotalal, Patient Care Coordinator and Administrative Liaison for the Decon Team at UMDNJ - University Hospital; Brian Dolan, Decontamination Team Captain, UMDNJ - University Hospital - Decontamination Teams within the hospital setting are a must and hospital administrations throughout the nation need to explore the ability to create and

maintain decon teams, because "it is not a matter of IF another 9/11 will happen, but a matter of WHEN". This Presentation will include: 1. The need for a decon team and the early stages in the development of the team. 2. The structure of the Team. 3. Choice of equipment presently utilized. 4. Training and meeting requirements for members of the team. 5. Retention of members. 6. The future of the Decontamination Team.

EMERGENCY MANAGEMENT WORKSHOP (Basic) (P)

Representatives of North, Central, and South Regions; New Jersey State Police Office of Emergency Management - An eight hour introductory course for personnel who are new to the field of emergency management. Subject material will include New Jersey Emergency Management Laws and Directives, the Integrated Emergency Management System, the Role of the Emergency Management Coordinator, Training, Exercising Programs and Disaster Recovery. This course may be attended by all New Jersey personnel in the emergency management field.

CEUs: Approved for 8 Elective CEU's by New Jersey State Department of Health & Senior Services - Office of Emergency Medical Services.

EOC Management and Operations (P) SFC Juan Munoz and Mary Goepfert, Field Training Unit, New Jersey State Police Office of Emergency Management - A two-day course which enables the participants to manage and operate an emergency operations center (EOC). Topics include EOC design, preparing, operating, exercising and evaluating the EOC, job aids, personnel management, NIMS guidance on multi-agency coordination systems, methods of requesting assistance and the importance of interfacing with on-scene command. This course will benefit state and local EOC managers, operations officers and other EOC staff, OEM coordinators, and Incident Commanders and staff. (APS requirement).

CEUs: Approved for 16 Elective CEU's by New Jersey State Department of Health & Senior Services - Office of Emergency Medical Services.

E-Team Basic User Class (P) Mr. Tom Rafferty, New Jersey State Police Office of Emergency Management - A four hour class on the basic use of E Team. Items covered in the class include how to log on to the system, how to post various reports (i.e. sitreps, resource requests, local conditions), how to monitor the software to gain situational awareness, and how to share data among the statewide E Team network. Attendees should be people who would staff an EOC during an activation.

CEUs: Approved for 4 Elective CEU's by New Jersey State Department of Health & Senior Services - Office of Emergency Medical Services Hydrologic River Forecasting and River Flooding Products (P) NOAA ~ National Weather Service - Various types of flooding common in New Jersey will be discussed, with an emphasis on riverine flooding throughout the state. The participant will be introduced to the end-to-end forecast process, including Quantitative Precipitation Forecasts, rainfall-runoff modeling, unit hydrographs, streamflow routing, stage-discharge relationships, and reservoir operations. Rain gage catch and radar estimated precipitation will also be discussed. A detailed description of the Advanced Hydrologic Prediction Service (AHPS) will also be presented, along with methods of interpreting various hydrometeorological products available on the internet from the National Weather Service.

CEUs: Approved for 4 Elective CEU's by New Jersey State Department of Health & Senior Services - Office of Emergency Medical Services.

ICS / EOC Interface (P) Mr. Michael Anderson and Mrs. Mary Goepfert, New Jersey State Police Office of Emergency Management - This course is designed to enable participants to develop ICS/EOC interface implementation strategies or action plans for their communities. The course reviews the ICS and EOC models of emergency management operations, including coordination, communication, and chief executive decision-making. It enhances knowledge and skills needed for clarifying roles, responsibilities, and relationships prior to a disaster through small and large scale exercises. This course is best suited for OEM personnel and responders who must operationalize the ICS/EOC interface in the field. This is neither an ICS nor an EOC operations course.

Prerequisite: It is strongly suggested that course participants attend an ICS 200 course as a prerequisite. (APS requirement)

New Jersey E Team Users Conference (P) Mr. Tom Rafferty and Mr. Mike Augustyniak, New Jersey State Police Office of Emergency Management - The State of New Jersey has been using the same version of E Team since the summer of 2004. Since then, many improvements have been made to the software and many areas identified where the software could be further improved. This day long session will include representatives from the software company who will discuss the future of the product and how it integrates with other systems (such as NC4, EPINet, CATS, local GIS sources, and more). Staff from NJOEM will discuss with participant various plans for upgrading the system. There will also be a feedback session in which the software company will listen to recommendations for software enhancements.

NJBF/NJEPA Private Sector Tabletop Exercise (P) William C. "Corky" Lowe and Colonel Hank Straub, New Jersey Business Force - The New Jersey Business Force (NJBF)/New Jersey Emergency Preparedness Association (NJEPA) Private Sector Tabletop will be divided into four phases. An orientation and situation update will be presented in phase one. Phase two shall focus on individual reactions/responses to specific scenario events. Phase Three will feature a collective review of unanswered questions surrounding Public-Private Sector integration and Private Sector roles in crisis response. Phase four will conclude exercise activities with a discussion of homeland security issues the Private Sector perceives as most pressing. New Jersey Business Force will replicate the TOPOFFIII Private Sector Roundtable as a three hour interactive private sector tabletop exercise for up to thirty conference attendees based upon the New Jersey venue of TOPOFFIII. Goals: While a comprehensive program like TOPOFFIII encompassed a range of objectives, identifying the elements essential for effective PublicPrivate partnerships was only one of a dozen core themes. The NJBF/NJEPA Private Sector Tabletop Exercise will be limited to addressing three overarching goals. 1. Create a unity of effort for combating terrorism by building new and constructive partnerships. 2. Clarify and solidify roles the Private Sector may perform during catastrophic events. 3. Craft a prototype for the evolving partnership between the Public and Private Sectors.

Prerequisite: The Exercise session will be open to thirty players with emphasis on the private sector and 10 observers with emphasis on the public sector.

WMD / CBRNE - Update **Not for the Faint of Heart** (P) Glenn Bukowski - Part 1: "Introduction to Explosives and IEDs for the Responder." To stop a terrorist, you have to know what their capabilities are. In past presentations, we've scared you with the possibilities of Improvised Explosive Devises (IEDs). Today we get to the 'nuts & bolts' of what is being used in other parts of the world and where criminals can find the parts to make these devices in your backyard. Topics include: Industrial Chemicals as WMD (those readily available in the industrial NE). How a terrorist might access information on local chemical supplies. Chemicals from retail sources that a terrorist can exploit. (a shopping trip to the "dollar store") Demonstrations and devices will be included. This lecture is a compilation of public information and commonly available knowledge. It uses no privileged information and represents one man's opinion of what a terrorist might do. Part 2: "Improvised Microbiology Labs: the Coming Nightmare" Biological weaponry is one of the hot topics for emergency responders and planners these days. This talk is one man's opinion as to what a clandestine weaponeer could do to "keep under the radar" and produce a deadly harvest. Topics include: the inventory of a commercial laboratory, commercially available lab materials, improvised lab equipment, sources of materials, the nature of improvised bioweapons We will address the educational and technical background required for a criminal to set up a lab and the "shopping lists" of materials that might trigger suspicions that such operations are taking place. There will be simulated lab specimens and models of improvised devices for the participants to examine. This lecture is a compilation of public information and commonly available knowledge. It uses no privileged information.

Prerequisite: **NOT FOR THE FAINT OF HEART** Attendee must be prepared to experience a presentation "THEY WILL NOT SOON FORGET".

Basic Incident Command System / I-200 (RES) Sgt. George Coyle, Sgt. Joann Harrison and Mr. Mike Anderson, New Jersey State Police Office of Emergency Management, Field Training Unit - This program includes five modules that describe the Principles and Features of ICS, Organizational Overview, Incident Facilities, Incident Resources, and Common Responsibilities Associated with ICS assignments. This program is 16 hours in length and attendees must be present at all sessions to receive certification. Attendees will receive a certificate from the New Jersey State Police for successful completion of I-100, I-200, and I-700.

CEUs: Approved for 16 Elective CEU's by New Jersey State Department of Health & Senior Services - Office of Emergency Medical Services. Caring for the Patient with Burns or Blast Injures (RES) Kathe M. Conlon, RN, BSN, CEM; Dr. Will Gluckman; Medical Director of UMDNJ; Mr. Gene O'Neill, New Jersey State Police Special Operations - Emergency management of burns and blast injures is one of the most significant challenges for EMS. In addition to initial injuries, associated with explosive pressure waves, these patients often experience the inhalation of noxious gasses or injuries from flying debris. Patient care may become complicated if the site becomes a crime scene. This presentation will focus on emergency management of blast and burn injuries while preserving a potential crime scene.

Incident Command System ~ Advanced/ I-400 (RES) Gary E. Seidel, Chief, Hillsboro CA; Fire Department, Asst. Chief (Ret.) LA City Fire Department - Special Operations; Leonard Carmichael, Captain, Trenton NJ Fire Department, Adjunct Faculty - National Fire Academy. Course Sponsored by the New Jersey Division of Fire Safety - This program emphasizes large-scale organizational development, roles and relationships of the primary staff, and planning, operational, logistical and fiscal considerations related to large and complex incident and event management. It describes the application of Area Command and the importance of inter-agency coordination on complex incidents and events. This program is 22 hours in duration, and the attendee must be present at all sessions to receive certification. This certification is required for all personnel who perform in Command and General Staff positions.

Prerequisite: Student must possess NWCG I-200 certification, NWCG I-300 certification, and must have completed the I-700 NIMS training program. Due to Limited seating, candidates for this training must be active Command Level Emergency Preparedness or Emergency Response personnel. Documentation of prerequisites will be required prior to approval of registration. Confirmations for this training program will be delayed until the attendee's credentials are confirmed. Intermediate ICS expands on the Basic ICS (I-200) program. The program includes indepth study and details about the organization and operation of ICS and management of resources. It describes the duties of all positions, including air operations, and provides examples of how the essential principles are used in incident and event planning. This course is required for all individuals who will function at the Unit Leader, Division or Group, and Command and General Staff positions.

Prerequisite: Student must possess NWCG I-200 certification, and must have completed the I-700 NIMS training program. Due to limited seating, candidates for this training must be active Emergency Preparedness or Emergency Response personnel. Documentation of prerequisites will be required prior to approval of registration. Confirmations may be delayed for this program until documentation is confirmed that the attendee has the proper credentials to attend. Please assure that your contact information is correct in your conference registration.

National Incident Management System I-700 / National Response Plan I-800 (RES) Kelly Hauler, MICP UMDNJ University Hospital EMS
Training Division, Camden, NJ - I-700: Introduction to the National Incident Management System (NIMS)The National Incident
Management System (NIMS). NIMS provides a consistent nationwide template that enables all government, private sector, and nongovernmental organizations to work together during emergency incidents. I-800: Introduction to National Response Plan (NRP)The NRP specifies how the resources of the Federal Government will work in concert with State, local, and tribal governments and the private sector to respond to Incidents of National Significance. The NRP is predicated on the National Incident Management System. Together the NRP and the NIMS provide a nationwide framework for working cooperatively to prevent or respond to threats and incidents regardless of cause, size, or complexity.

CEUs: Approved for 4 Elective CEU's by New Jersey State Department of Health & Senior Services - Office of Emergency Medical Services

NWCG ICS I-200 Train the Trainer (RES) SFC Juan Munoz, Sgt. George Coyle and Sgt. Joann Harrison of the New Jersey State Police Office of Emergency Management, Field Training Unit - The I-200: "Basic Incident Command System" Instructor program. Certificates will be provided upon successful course completion by the New Jersey State Police.

Prerequisite: Student Candidate must possess ICS 200 certification 12 hour course, certificate of completion from the EMI ICS 200 online training course, and must have completed the I 700 NIMS online training program. Candidate must also be an active instructor, having completed a Methods of Instruction program or NJDFS Certification as an Instructor -Level 2. Documentation of prequisites will be required prior to approval of registration. Please assure that your contact information is correct in your conference registration. Confirmations may be delayed for this program until the attendees credentials are confirmed.

WMD - HazMat Crime Scene & Evidence Collection (RES) U.S. Department of Homeland Security Office for Domestic Preparedness Training - AWR-103 "Crime Scene Management for Emergency Responders." This course provides emergency responders with an understanding of the crime scene process. Responders will also learn how to assist in crime scene protection and interact with crime scene investigators. This awareness-level course was developed to serve the needs of emergency responders who have no previous training in responding to weapons of mass destruction (WMD) crime scenes. PER-201 "WMD HazMat Evidence Collection." This operations-level course provides instruction in how to collect weapons of mass destruction (WMD)hazardous materials evidence and ensure that collection protocols are followed and that proper chain of custody is maintained. This meets the guidelines identified by the Federal Bureau of Investigation's Hazardous Materials Response Unit (HMRU). Emergency responders may be asked to assist in hazard risk assessment and to act as crime scene specialists in collecting evidence at the direction of crime scene investigators. Public safety personnel will receive the skills

and knowledge to effectively collect hazardous criminal evidence as crime scene specialists under the direction of law enforcement personnel. The two-day course consists of classroom hours and a practical scenario. This program is being offered as a single 24 hour program, and all sessions must be attended to receive certificates of completion. Certificates will be provided by the U.S. Department of Homeland Security, Office of Domestic Preparedness Training.

Prerequisite: Due to the limited number of seats available, active Crime Scene Technicians / and Hazardous Materials Response personnel will receive priority seating. This may cause attendee confirmations to be delayed. Please assure your contact information is correct on your registration information.

WMD Emergency Response to Terrorism (RES) Mark Chapman, Nelson Wiest, Jack Deangelo, Pat Dolgos, Dennis Kappler, Emergency Medical Services Academy of Underwood Memorial Hospital. - The WMD Emergency Response to Terrorism course is a program designed to provide emergency responders operational level instruction on responding to and operating in a WMD environment. In addition, it provides hands-on familiarization training with specialized protective clothing, chemical detection and identification equipment, decontamination and triage. This course is designed for emergency responders in Fire Service, Law Enforcement, Emergency Medical Services, Emergency Management and Emergency Communication who would like to enhance their awareness and operations level training. This is a 20 hour class, and attendees must attend all sessions to receive a certificate. This program is not designed to meet the needs of a Haz-Mat Technician. Certificates will be issued by The Emegency Medical Services Academy of Underwood Memorial Hospital.

Prerequisite: Candidate for training must be in a first response role or Emergency Management agency. This course is not intended for Technician Level Responders. This is a 20 hour class; Attendees must attend all class sessions to receive a certificate. Please assure your contact information is accurate in your conference registration.

CEUs: Approved for 20 Elective CEU's by New Jersey State Department of Health & Senior Services - Office of Emergency Medical Services.

Emergency Services Stress - Tools for Survival (REC) Cherie Castellano, UMDNJ - UBHC, Director of Lifeline and Cop2Cop. -Emergency Services personnel are required on a daily basis to manage situations and maintain control over their own emotions and the emotions of those in crisis. The aftermath of controlling the overwhelming emotions of any crisis can be staggering, and can lead to alcoholism, divorce, or suicide. The primary objective of this program is to increase the awareness of the audience about the impact stressrelated issues can have on their daily lives, and educate them as to what actions they can take to minimize these effects and prevent unnecessary consequences. The target audience will gain knowledge of the following: 1. Types and indicators of stress. 2. Personality profile and susceptibility to ancillary stress. 3. Critical Incident Stress & PTSD. 4. Protective Measures / Stress Management. 5. Suicide prevention. This lecture will utilize a PowerPoint presentation and a short video in which rescuers discuss the impact of stress on their lives.

CEUs: Approved for 4 Elective CEU's by New Jersey State Department of Health & Senior Services - Office of Emergency Medical Services.

NTSB / Transportation Disaster Response Course for Emergency Responders (REC) James A. Arena, Chief Technical Advisor, Strategic and Intergovernmental Operations, National Transportation Safety Board - In consideration of the critical role that emergency responders play in response to major transportation accidents and crimes, a

curriculum targeting this population, brings together leadership from emergency response disciplines, other federal agencies with authority and the transportation industry, to share knowledge and enhance community readiness. Participants will explore the issues surrounding a major transportation accident or criminal event. The curriculum includes the management of on-scene disaster response and security, effectively documenting and gathering evidence, handling post-accident public relations, working with families, understanding the forensic recovery and identification processes, and overall transportation emergency management, all from the emergency response perspective. The approach for this presentation will make use of actual Safety Board investigations in different modes of transportation and other situations such as TWA 800, American Airlines 587, Fox River Grove train/school bus and others to highlight examples of important aspects of transportation disaster responses. At the conclusion of the course, emergency responders will have learned from the experiences of other communities involved in major transportation disaster response, and will have acquired basic knowledge of skills that will help them prepare their own resources in advance and perform their responsibilities more effectively in the future.






