





Green Paper on mHealth: Conclusions and Actions

The joint plenary will provide an overview of the results of the public consultation in the context of the Commission's Green Paper on mHealth. Different stakeholders — patients, providers, health professionals, health authorities and industry — will present and discuss their views on what it takes to achieve a wider uptake and implementation of mHealth in Europe and what kind of action should be taken at EU, national and regional level. Lessons learned from existing mHealth initiatives will be identified, including the question how to overcome barriers of implementation.

Topics covered by speakers and panelists include:

- What could be the role of different stakeholders to increase trust in mHealth applications and facilitate consumer choices? What could be the role of regulation and standardization in supporting innovation and creating trust?



Life isn't about a disease or condition. It is about living! In the Netherlands we aim for high quality care in the comfort of our own homes. eHealth provides us with the digital tools to feel safe and supported by our family, social environment and health care providers. By remote monitoring, video conferencing, and tools for personal protection patients can be more independent. They can forget about being a patient and start becoming a person again. 


