OCYF promotes a kinship-first culture in all areas of service offered:

Act 55 of 2013 – PA Family Finding law

- Requires family finding efforts to occur on an ongoing basis for all children entering the child welfare system.
- Conducted initially when a child is accepted for services and at least annually

Rule 1149 Family Finding requires PA Courts, at each stage of a case, to:

- Inquire about the efforts made by the county children and youth agency to comply with the family finding requirements pursuant to PA law.
- Place a determination on the record as to whether the agency has reasonably engaged in family finding efforts.

Pennsylvania Statewide Adoption and Permanency Network

- SWAN began in 1992
- Public/private partnership devoted to achieving permanency for children in foster care.
- Overseen by the Department of Human Services and is managed by a prime contractor,
- Prime contractor maintains subcontracts with approximately 75 private agencies, referred to as SWAN Affiliate Agencies
 - Affiliates provide direct services to children in care and the families who serve them.



Families who provide permanency to children from the child welfare system through Permanent Legal Custodianship or Kinship Care (fit and willing relatives)

Kinship Champion Curriculum

2020 Pilot

Training to support OCFS efforts in developing dedicated "Kinship Champions" within LDSSs and voluntary agencies who will search for, engage, notify, and assess potential kin caregivers, and provide support to those families

KinGAP Targets

Child in foster care with kin 6 months + per LDSS

Goal is not return to parent or adoption

Follow up by OCFS permanency specialists

KINSHIP CGS SEC 17A-114

Kinship Defined

- Relative (Kinship) Caregiver- Related by birth, adoption or marriage
- Fictive Kin Caregiver Unrelated to a child but has an emotionally significant relationship with child or child's family amounting to a familial relationship

Mandate

- No child in custody of the Commissioner shall be placed in foster care with any person unless such person is licensed
- A child in the custody of the Commissioner may be placed with a relative or kin who has not been issued a license or approval...provided a satisfactory home visit is conducted; a basic assessment of the family is completed.

WAIVERS- COMMISSIONER LEVEL

Sec. 17a-145-152a

Individual has been CONVICTED

- Injury or risk of injury to minor or other similar offenses against a minor
- Impairing the morals of a minor or other similar offenses against a minor;
- Violent crime against a person or other similar offenses;
- Possession, use, or sale of controlled substances within the past five (5) years;
- Illegal use of a firearm or other similar offenses;
- Child abuse or neglect substantiated; or
- has had a minor removed from their care because of child abuse or neglect

The History and Explanation

- Criminal History & CPS History
- Details of the explanation
