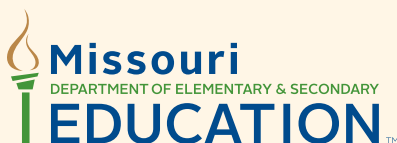

Margie Vandeven

Dr. Margie Vandeven is Missouri's Commissioner of Education. She is passionate about ensuring that each child has the opportunity to graduate prepared for success. She has more than 30 years of student-centered service in education, including six at Missouri's top educational post. She is a teacher who has provided educational leadership in the classroom and in school, state, and national roles assumed throughout her career.

Dr. Vandeven joined the department in 2005. She was appointed commissioner of elementary and secondary education by the Missouri State Board of Education in December 2014 and served in that capacity until December 2017. She was reappointed in January 2019. During the interim, Vandeven worked as the director of educational partnerships for the SAS Institute in Cary, N.C. As commissioner, Dr. Vandeven works collaboratively with a diverse group of stakeholders to improve educational opportunities for Missouri's nearly 900,000 public school students.



Chelonnda Seroyer

Chelonnda Seroyer began her career in education as a high school English teacher in Madison, Alabama. She used *The First Days of School* by Dr. Harry Wong as an instruction manual to set up her classroom. At the end of her second year of teaching, she was awarded the Patriot Award in recognition of her valuable contributions, dedication, and service to the educational community. At the end of her fourth year, she was recognized as Teacher of the Year.

Seroyer was an executive member of the Madison City Schools' New Teacher Induction Team where she helped coordinate the induction program for new teachers coming into the school system. She is president and CEO of Seroyer Educational Consulting Service and conducts solo presentations for a variety of school districts (including schools in Puerto Rico, Hawaii, St. Thomas, St. Croix, and Canada). Seroyer also has presented with Dr. Wong both nationally and internationally.

Since the initial passage of ESEA in 1965, nonpublic school students and teachers have been eligible to participate in specific Title programs. The reauthorization of ESEA into the Every Student Succeeds Act (ESSA) in 2015 continues this requirement that an LEA receiving Title funds must provide equitable services to eligible nonpublic school students, their teachers, and their families. Participants in this session will learn requirements from consultation to evaluation, who is responsible for each requirement, and how best to build and sustain the relationship between LEAs and nonpublic schools.
