

**Canadian Crops Convention, brought to you
by the Canola Council of Canada and the
Canada Grains Council
Early Bird Draw - 2022**

HOW TO PLAY

1. TO PLAY: Commencing on or about November 24, 2021, pre-registered full delegates attending the 2022 Canadian Crops Convention at the Westin Ottawa, 11 Colonel By Dr, Ottawa, Ontario will be automatically entered into the promotional contest. The contest will close to all participants by January 21, 2022 at 11:59 pm CST. The promotional draw will be held over staggered dates (reference Table 1). To increase your odds in winning both prizes, register before December 15, 2021 at 11:59 pm CST. All winners will be re-entered into the next draw. The prizes will be sent to the winner's home address as provided.

*NOTE: The Canola Council of Canada (CCC) reserves the right in its sole discretion to reject any contest ballot that is not presented in its entirety and also the right to limit the number of ballots received to 500 entries. Limit of 1 entry per person. For odds of winning reference Table 2.

2. NO PURCHASE NECESSARY TO PLAY: Obtain one free CCC promotional contest ballot per person and/or a copy of the official rules, by writing to: Canola Council of Canada, 400-167 Lombard Avenue, Winnipeg, MB R3B 0T6 Canada.

Limit of one request per envelope with sufficient postage, while supplies last. Not open to residents outside of Canada. No mechanical reproductions of requests permitted. All requests must include a postage-paid, self-addressed envelope.

BALLOTS

A total of 500 ballots will be accepted for this contest. Limit of 1 entry per person (pre-registered full delegates will be entered automatically. One free ballot per person is available by mail upon request while supplies last). All requests must include a postage-paid, self-addressed envelope. Telephone, fax or e-mail requests will not be accepted when requesting one free ballot.

A) One (1) Amazon Echo Dot (4th generation, charcoal) Smart Speaker with Alexa and Sengled smart light bulb. Approximate retail value is estimated to be \$35 CDN before any applicable taxes.

One (1) Amazon Fire HD 8 tablet (black). Approximate retail value is estimated to be \$110 CDN before any applicable taxes.

Country of residence is limited to Canada. The CCC promotional prize must be accepted as awarded in the form solely decided upon by the CCC.

GENERAL RULES

5. Contest commences on or about November 24, 2021 and contest closes on January 21, 2022 at 11:59 pm CST. A total of 500 ballots will be accepted for this contest (pre-registered full delegates will be automatically entered). One free ballot per person is available by mail upon request while supplies last. Limit of 1 entry per person. Telephone, fax or e-mail requests will not be accepted when requesting one free ballot. All ballots will be individually numbered, inspected, produced and confirmed to be completely legible. Those which do not appear to be valid will not be accepted.

6. Contest ballots obtained through unauthorized sources or which are incomplete, mutilated, altered, reproduced, forged, counterfeited or irregular in any way, are automatically void. Submission of entry ballots is the sole responsibility of the individual seeking verification. No entry ballot copies,

duplicates or reproductions of any type will be eligible for the contest. The CCC is not responsible for any lost entry ballots. CCC staff are not allowed to submit an entry ballots or on behalf of a potential winner.

7. Prize claimant must be a resident of Canada. To be eligible to claim a prize, prize claimants must have reached the age of majority in their jurisdiction of residence or in the event a person under the age of majority receives an eligible entry ballot, they are permitted to transfer the entry ballot to their parent or legal guardian, who will then be the eligible entrant.

8. Employees of, members of the immediate family of, or those domiciled with an employee of the CCC, are not eligible to participate. "Immediate family" is defined as parents, siblings, children or spouse.

9. By participating in this contest, entrants agree to be bound by these rules and all decisions of the CCC, which are final. Without limitation, the CCC reserves the right to administer a skill-testing question to Canadian residents as it deems appropriate to address discrimination or disability issues.

10. Prizes must be accepted as awarded and are not convertible to cash. Winning entry ballots are not transferrable or converted to cash except as specifically provided herein. Prizes may not be exactly as shown in promotional materials. In case of unavailability of any prize, to accommodate for a disability, or for any other reason and in CCC's sole discretion, the CCC reserves the right to substitute a prize for a prize of equal or greater value.

All prize claims become the property of the CCC and no correspondence will be entered into except with potential winners.
