CaliQity

California's No Cost e-Learning Platform



In June of 2010, IQ Innovations partnered with the California K-12 High Speed Network (K12HSN). The agreement, which is in place until 2020, gives all schools in California access to the LMS and the Marketplace. IQity was rebranded as CaliQity for the state. California schools are the first in the nation to have access to a true curriculum marketplace.


















Why Now & Why This Course



E-rate requirements for CIPA compliance are the driving force...

- ✓ Effective July 1, 2012
 - Updated Acceptable Use Policy (AUP) & Certifications
 - Annual Instruction for students
- ✓ Changes align to AB 307




New Certifications: Protecting Children in the 21st Century Act

Quoted from USAC:

Note: beginning July 1, 2012, when schools certify their compliance with CIPA, they will also be certifying that their **Internet safety policies have** been updated to provide for educating minors about appropriate online behavior, including interacting with other individuals on social networking websites and in chat rooms, cyberbullying awareness, and response.


Why Now



AB 307 (Chavez)


- ✓ Signed into law in August 21, 2006
- ✓ Compliance grandfathered via Ed Tech Plan (formerly EETT) renewal, Sections 3 f & 3 g, from 2007 - 2012
- ✓ CDE's expectation requires professional development for ALL staff and instruction for ALL students ANNUALLY

Why Now



AB 307 states. . . the guidelines and criteria shall include a component to educate pupils and teachers on the appropriate ethical use of information technology in the classroom, Internet safety, the manner in which to avoid committing plagiarism, the concept, purpose, and significance of a copyright so that pupils are equipped with the skills necessary to distinguish lawful from unlawful online downloading, and the implications of illegal peer-to-peer network file sharing.





Why This Course

- ✓ Aligns to new E-rate/CIPA requirements




Anticipated Deployment

Models within Ventura County Districts


- ✓ High School District
 - Broadcast 2nd period to all sites (extra 10 minutes)
- √ VCOE Special Education
 - Student independent with supervision
- ✓ Unified School District
 - Parent with student prior to start of school

Actual Deployment From Lessons Learned




Actual Ventura County Models

- ✓ VCOE Special Education
 - Teacher led whole group instruction
 - Modified courses (available soon)
- ✓ VCOE Court & Community
 - Student independent with supervision
 - Students receive computer class credits
- ✓ Unified School District
 - Responsible Use Lesson for every student
 - Specific lessons/videos for identified grades within each course for all students




Deployment Roadmap

- ✓ Determine district timeline & delivery model(s)
 - Consistency across district
 - Grade levels may vary
 - Maintain records for CIPA compliance
 - ✓ Proof of delivery
 - ✓ Student attendance
- ✓ Provide PD opportunities for all staff
 - F2F/online/blended
