WHAT IS THE IAU WHED?

- IAU in collaboration with UNESCO since 1950
- > IAU World Higher Education Database (WHED) is an online reference portal
- Information on some 19,400 HEIs, and higher education systems and credentials of 196 countries and territories
- > HEIs listed are accredited or recognized by their respective national authorities
- WHED is a vast source for HE information provided and used by national higher education authorities, governmental agencies, national academic bodies



WHAT KIND OF INFORMATION IS ON WHED?

Education system and credentials

- **Fact sheet:** structure of national HE system and credentials including:
- types of HEIs available in the country
- structure of the higher education system
- national bodies responsible for higher education (including associations and organisations located within the country)
- admission requirements
- the quality assurance and recognition systems
- the main credentials

Higher education institutions (HEIs)

1. Fact sheet divided into 5 sections:

- General information
- Divisions
- Degrees
- Student and Staff numbers

2. The profile of **IAU Members** are highlighted with the IAU flag and their logo and photos if available



WHO PROVIDES INFORMATION?

National competent bodies:

- > National higher education authorities and governmental agencies
- > For each degree-granting institutions offering at least a 4-year degree
- > questionnaire is sent out to the HEIs to check and update institutional data
- 1. National competent bodies, 2. troubleshooting: Permanent delegations at UNESCO



Inclusion criteria for a country

Be a Member State or an Associate Member of the UN

> Inclusion criteria as Higher Education Institution

✓ Be recognized and referenced by the national competent body
✓ Be a degree-conferring institution offering at least a four-year degree or a four-year professional diploma
✓ Have had at least three cohorts

Common good: local to global?

- "Everyone has the right to leave any country, including his own, and to return to his country" (UN's Declaration of Human Rights, 1948)
- **Global Convention: legal right** to have qualifications assessed for admission to further study or employment in another country
- Adoption: UNESCO's General Conference
- IAU contributes through WHED: facilitator for the freedom of movement as a go-to tool for the recognition of foreign qualifications

- As only database that lists all accredited/recognised HEIs in the world, the WHED is a hugely important facilitator!
- HE Recognition requires trust: enhanced if information easily obtainable from open, quality controlled websites and standardised databases
- WHED part of the process in order to provide: verified, trustworthy information about the degree conferring institutions and the education system to make a fair assessment of the qualification.
- gate-opener for academic and professional mobility
- gate keeper safeguarding the integrity of HE qualifications and HE institutions

Simplified access to identify accredited institutions

In collaboration with UNESCO and other partners, including the AUF, the ACU, and ENIC-NARIC Network:

- Foster transparency of higher education on a global scale;
- Help Higher Education stakeholders to identify accredited/recognised HE institutions
- Increase access, speed and the reliability of information;
- Provide better overall **administrative certainty**;
- Combat fraud in higher education

HOW IS THE INFORMATION UPDATED?

Regional updates

The IAU/UNESCO Information Centre updates the database in collaboration with UNESCO and the ENIC NARIC Networks on **an ongoing basis according to a 4-year cycle focusing each year on one specific region or geographic area**.

For year 2019-2020 Europe, Canada and North America are being update.

Following regions will be update according to this cycle:

- Latin America and the Caribbean (2020-2021)
- Africa (2021-2022)
- Asia, Oceania and Middle East (2022-2023)

Monthly updates

The IAU/UNESCO Information Centre also provides monthly updates on IAU Members, ad hoc updates received from institutions, and regular updates on national higher education systems and bodies.
